

Sub: 6-laning of Barwa-Adda-Panagarh Section of NH-2 from Km. 398,240 to Km.521.120 including Panagarh Bypass in the states of Jharkhand and West Bengal under NHDP Phase V on Toll on DBFOT Pattern: Proposal for permission for laying of 220 KV Overhead electrical line to be laid across NH-2 between Km 417+200 to Km 417+240 of Jharkhand Urja Sancharan Nigam Ltd. – Reg.

The Project Director, PIU-Durgapur, NHAI vide letter no : 15017/1/2013/PIU(DUP)/JUSNL/417.200 - 417.240/7504 dated 05.07.2024 has submitted the subject mentioned proposal for granting licenses for use of National Highway land.

2. The proposal for laying 220KV Over Head electrical line crossing of NH-19 (Old NH-2) is under:

Location (chainage)	Remarks
Km 417+200 & Km 417+240 (at crossing)	Transmission Circle, Dhanbad, JUSNL has proposed to lay 220KV Overhead electrical line at the cited location. The tower's are placed outside RoW. Vertical clearance is as per IRC:32.

- As per Ministry guideline issued vide no RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the Highway
 Administration shall make available the proposal for granting license for use of National Highway land for
 laying Utility service for public comments for 30 days on ground of public interest.
