It is to submit that the Dy. Executive Engineer, M/s. APTIDCO, Vijayawada, vide reference letters 1st & 2nd cited, submitted proposal in MoRT&H Portal vide Application No.20250528/1/7/12779/16564 dated 28.05.2025 and requested Permission for Laying Utility Pipeline Across NH-65 at Km.267+440 from RHS to LHS at Gollapudi Village, Ibrahimpatnam Mandal, N.T.R.District on Nandigama - Vijayawada section on NH-65 in the State of Andhra Pradesh.

2. In this connection, Upon request from PIU vide letter ref 3rd cited, the IE vide reference letter 4th cited conducted site inspection and reviewed the subject cited proposal as per the norms of MoRT&H vide Circular No. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016& NH-36094/01/2022-S&R (P&B) (E-208825) dated 24.04.2023 and subsequent amendments, and raised certain observations and in turn PIU vide reference letter 5th cited communicated the same to the Dy. Executive Engineer,

APTIDCO, Vijayawada for compliance and requested to submit revised proposal accordingly.

- 3. Subsequently, The Dy. Executive Engineer, M/s. APTIDCO, Vijayawada vide reference 6th cited submitted the revised proposal and again the PIU forwarded the revised proposal to the IE for further verification and submission of report/comments.
- 4. Accordingly, the IE, M/s. Theme Engineering Services Pvt. Ltd., vide reference letter 7th cited, informed that they have verified the revised proposal and observed the applicant has complied all the observations communicated. It was further informed that the Checklist, Drawings, Undertakings, Draft Agreement are found in order and recommended for approval of Competent Authority to accord permission for Laying Utility Pipeline across NH-65 at Km.267+440 from RHS to LHS at Gollapudi Village, Ibrahimpatnam Mandal, N.T.R.District on Nandigama -Vijayawada section on NH-65 in the State of Andhra Pradesh. The Comments / Recommendations of the Independent Engineer and proposing Authority NHAI, PIU Vijayawada are as under:
 - a) The Dy. Executive Engineer, APTIDCO, Vijayawada, has proposed for Laying Utility Pipeline across NH-65 at Km.267+440 from RHS to LHS at Gollapudi Village, Ibrahimpatnam Mandal, N.T.R.Dist on Nandigama -Vijayawada section on NH-65 in the state of Andhra Pradesh.
 - b) The length of crossing at Km 267+440 is 32.50m
 - c) HDD Method (Horizontal Directional Drilling method) is proposed for crossing of the highway at Km. 267+440.
 - d) The width of ROW at Km. 267+440 is 15.5m towards RHS and 17m towards LHS for the center line of the highway.
 - e) Checklist is in accordance with MoRT&H Guidelines enclosed for laying of utility pipeline on NH land and the same is found in order.
 - f) Draft License Deed is in accordance with the MoRT&H Guidelines.
 - g) Construction of Methodology for laying utility pipeline by HDD method is enclosed, which is found in order.
 - h) Cross section showing the size of utility pipeline for HDD method is enclosed.
 - i) Strip plan / Route plan for laying of utility pipeline and distance from nearest structures to road crossings is mentioned in drawings, are enclosed.
 - j) Necessary undertakings are submitted by applicant which are in accordance with MoRT&H Guidelines.
 - k) Undertaking submitted by the applicant for requisite Performance Bank Guarantee Rs.250/- per route meter along with License fee for 5 years as per MoRT&H Guidelines dated 22.11.2016.

- l) Calculation sheet for License Fees & Performance Bank Guarantee submitted by applicant is enclosed, which is found in order.
- m) Certificate from PD that the proposal is confirming to all standard conditions issued vide MoRT&H Circular No. RW/NH/33044/29/2015/S&R(R) dated 22.11.2016 & MoRTH Circular No.RW/NH-36094/01/2022-S&R(P&B) dated 24.04.2023 is enclosed.

Name of Work: Proposal for Laying of utility pipeline 1000mm dia across NH-65 at Km.267+440 from RHS to LHS at Gollapudi Village, Ibrahimpatnam Mandal, N.T.R.Dist on Nandigama -Vijayawada section on NH-65 in the state of Andhra Pradesh

As per para 2.5.2 MoR&TH guidelines dated 26.06.2020." Proposal was verified and recommended by Site Engineer(T) and the documents accompanying the proposal as below:

- i) The Dy. Executive Engineer, APTIDCO, Vijayawada, has proposed for Laying Utility Pipeline across NH-65 at Km.267+440 from RHS to LHS at Gollapudi Village, Ibrahimpatnam Mandal, N.T.R.Dist on Nandigama -Vijayawada section on NH-65 in the state of Andhra Pradesh.
- ii) The length of crossing at Km 267+440 is 32.50m
- iii) HDD Method (Horizontal Directional Drilling method) is proposed for crossing of the highway at Km. 267+440.
- iv) The Proposed pipeline of 1000mm dia will not disturb the existing crust of National Highway at the above said location as the pipeline will be laid at a depth of 1.5m below ground level.
- v) The distance between the nearest structures to proposed crossing of water pipeline is more than 15m as against minimum requirement of 15 m and mentioned in Item No.1.19 C of Check list
