INVITATION OF PUBLIC COMMENTS

Sub:- NHAI-RO Kerala-Four Laning of Walayar-Vadakkencherry section of NH-544 in the State of Kerala-Laying/Crossing of Natural gas pipeline on NH 544 by M/s Indian Oil-Adani Gas Pvt. Ltd (IOAGPL) from Km.191+900 to Km.205+050 (laying from Km.191+900 to Km.192+940-LHS, Km.192+940 to Km.193+575-LHS, Km196+340 to Km.196+940-LHS, Km200+900 to Km.205+015-LHS Km192+940 to Km200+900-RHS, Km.204+760 to Km.205+015-RHS and crossings at Km.192+940 from LHS to RHS, at Km196+940 from RHS to LHS, at Km.200+900 from RHS to LHS & at Km205+015 from LHS to RHS) for a total length at LHS is 6.390Km, at RHS is 8.215Km and crossing length is 0.185Km -Reg.

The proposal is regarding permission sought by M/s Indian Oil-Adani Gas Pvt. Ltd (IOAGPL) for laying/Crossing of Natural gas pipeline on NH 544 from Km.191+900 to Km.205+050 (laying from Km.191+900 to Km.192+940-LHS, Km.192+940 to Km.193+575-LHS, Km196+340 to Km.196+940-LHS, Km200+900 to Km.205+015-LHS Km192+940 to Km200+900-RHS, Km.204+760 to Km.205+015-RHS and crossings at Km.192+940 from LHS to RHS, at Km196+940 from RHS to LHS, at Km.200+900 from RHS to LHS & at Km205+015 from LHS to RHS) for a total length at LHS is 6.390Km, at RHS is 8.215Km and crossing length is 0.185Km in the subject project stretch in the State of Kerala.

2. M/s IOAGPL has furnished undertaking to shift the underground Gas Pipeline at their own cost at an alternate location whenever NHAI or any other road authorities make a request for shifting of the same. Further, the applicant has undertaken to confirm with all standards as mentioned in the Ministry's Circular No. RW/NH-33044/29/2015-S&R dated 22.11.2016.

3. Further, M/s IOAGPL has undertaken that they will not damage any other utility during the process on laying and in case, if damaged, then to pay the losses either to NHAI or to the agency concerned. M/s IOAGPL has also undertaken to manage traffic movement during the execution of the work.

4. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by M/s IOAGPL will be made available for 30 days seeking public Comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
