- 1). The subject proposal is requesting permission for laying of Water Pipeline along the road of NH-45 by open trench method of 350 mm Dia GI Pipe from Km. 186/600 to Km.193/800 in the project stretch of Tindivanam to Ulundurpet Section in the State of Tamil Nadu.
- 2). The Commissioner, Ulundurpet Municipality, Kallakurichi has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, if NHAI considers it as necessary, in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 90 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No.RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.

As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by The Commissioner, Ulundurpet Municipality, Kallakurichi will be made available for 30 days seeking public comments / objection and shall be furnished within 30 days from the day of closure of public objections.
