The Roads and Building Department, Government of Gujarat vide letter no. NHP-13-2025-331-M dated 06.05.2025 has recommended the subject cited proposal for permission for laying proposed 8" dia carrier natural gas pipe encased with 12" mm dia casing pipe from existing receiving station at village Samadhiyala No 1 Taluka Botad, Dist Botad to Shivrajpur village, Taluka Jasdan District Rajkot crossing at km 114/692 on NH - 51 in the State of Gujarat for approval of Highway Administration cum RO, Gandhinagar.
