Sub: Desing, Engineering, Finance, Construction, Operation and Maintenance Chhattisgarh/ Maharashtra Border- Wainganga Bridge Section from km. 405.000 to km. 485.000 of NH-53 (Old NH-6) in the state of Maharashtra on BOT (Toll) under NHDP Phase IIIA on Build, Operate and Transfer (BOT)- Submission of proposal for laying / crossing at Near Forest Office, Deori, village of Sixteen (3) locations of 11 KV Deori Electrical Feeders XLPE Cable of 300 sqmm 3 core across the NH-6 under Deori Division of Gondia Circle -Reg.


