- Sub: NHAI, PIU, Coimbatore Six / Four laning of Chengapalli to Walayar Section of NH-544 from km 102/035 to km 144/680 & from km 170/880 to km 183/010 -Laying of underground water supply pipe line along the road 300mm dia DI and 140mm dia HDPE water pipe line along the road from km 121/700 to 122/180 (LHS & RHS) & Road crossing km 122/180 and 100 mm dia DI & 160mm HDPE water pipe line along the road from km 126/635, 75mm dia HDPE water pipe line km 126/635 to 126/970 (LHS) & road crossing at km 126/635, 75mm dia HDPE water pipe line km 126/970 to 127/950 (LHS) & 250mm dia DI water pipeline km 126/955 to 127/220 (RHS) of Salem -Cochin Road on NH-544 - Coimbatore and Tiruppur in Tamilnadu State - Reg.
- 1. The proposal is regarding permission for laying underground water supply pipeline on the above said project chainages by open trench / HDD method for a length of 3835 m along the road and Two road crossings by Tamilnadu Water Supply and Drainage Board.
- 2. Tamil Nadu Water Supply and Drainage Board, has furnished an undertaking to accept any claims raised by the Authority, if any and the same will be paid by them and also furnished undertaking not to damage other utility, if damaged, then to pay the losses either to NHAI or to the concerned agency.
- 3. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/ S&R(R) dated 22.11.2016, the proposal submitted by Tamilnadu Water Supply and Drainage Board, will be made available for 30 days seeking public comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
