Invitation of Public Comments


Sub: NHAI, PIU, Coimbatore - Request for permission to lay underground Optical Fibre Cable (OFC) on Pollachi - Coimbatore Section of Dindigul - Bangalore Road, NH-209 between km 147/235 to km 149/250 (RHS) and across @ km 147/080 @ km 147/210, @ km 149/300 of NH-209 - Reg.

1. The proposal is regarding permission for laying Optical Fibre Cable (OFC) on the above said project chainages along the road from km 147/235 to km 149/250 (RHS) and across the road from km 147/080, km 147/210, km 149/300 by Open trench / HDD method as per site condition for a length of 2131 m by M/s.Jio Digital Fibre Private Limited, Mylapore, Chennai.
2. M/s.Jio Digital Fibre Pvt Limited, Chennai has furnished an undertaking to accept any claims raised by the Authority, if any and the same will be paid by them and also furnished undertaking not to damage other utility, if damaged, then to pay the losses either to NHAI or to the concerned agency.
