Please find enclosed No.25-10/12/2020-PG dated 21st September 2020 from Under Secretary, Ministry of Power enclosing therein the Minutes of the Meeting held between Ministry of Power (MoP) and Ministry of Road Transport and Highways (MoRTH) through Video Conference on 15.09.2020 on the issue of Supervision charges for shifting of Transmission Lines under Bharatmala Pariyojana.

Bharatmala Pariyojana (Project) is a centrally-sponsored and funded Road and Highways project of the Government of India. The project will build highways from Gujarat, Rajasthan, Punjab, Haryana and then cover the entire string of Himalayan states i.e. Jammu and Kashmir, Himachal Pradesh, Uttarakhand and portions of borders of Uttar Pradesh and Bihar alongside and move to West Bengal, Sikkim, Assam, Arunachal Pradesh, and right up to the Indo-Myanmar border in Manipur and Mizoram. Special emphasis is being given on providing connectivity to far-flung border and rural areas including the tribal and backward areas.

POWERGRID Transmission Lines infringing into the corridor of the upcoming Bharatmala Pariyojna shall be shifted by NHAI/ any other execution agency of MoRTH themselves under supervision of POWERGRID to ensure quality of material and work and compliance of POWERGRID FQP in field execution. Considering the importance of the said Bharatmala Pariyojana, special dispensation has been granted for levy of Supervision Charges (Consultancy Fee) @ 2.5 % of the Project Cost to be charged by POWERGRID from the executing agency wherever the shifting of POWERGRID Transmission Lines in Bharatmala Pariyojna Corridor is carried out by the executing agency themselves under supervision of POWERGRID.

It is requested to communicate the above for compliance to all the TLM / TLC offices of POWERGRID functioning under various Regions for their information and compliance.

List of participants is at Annex-I.

- 2 It was noted that under the Bharatmala Pariyojna approved by the Cabinet, MoRTH and its project implementing agencies have pegged the supervision charges in case of utility shifting @ 2.5% of the cost estimates. However, POWERGRID is presently levying Supervision Charges @15% for such shifting MoRTH/NHAI has requested that the supervision charges by POWERGRID may be fixed at 2.5% for the Bharatmala Pariyojana.
- 3. Considering the importance of Bharatmala Pariyojana of NHAI and request of MORTH/NHAI for reconsideration of the supervision charges, CMD, POWERGRID agreed to levy supervision charges @ 2.5% of the Project Cost for shifting of transmission lines under Bharatmala Pariyojana.
- The meeting ended with thanks to the Chair.

[In pursuance of decision taken in 414th meeting on agenda item no. 414.04]

Sub: Delegation of powers for matters pertaining Highway Administration to Regional Officers of NHAI.

The matter was discussed in the Executive Committee and decision is as under:

EC directed to delegate the powers to the Regional Officers of NHAI to decide on granting prior permissions on various proposals under section-38 of land & traffic Act. While granting such permissions, ROs may convey that the charges would be payable as decided and being conveyed separately by NHAI. The delegation given may be conveyed to MoRTH along with a proposal to approve the charges to be levied in various cases keeping in view the charges being levied by State Govt. Departments/ Agencies on NHAI for shifting of utilities etc."

- 2. As per the provisions of Section-20 of the Control of National Highways (Land & Traffic) Act, 2002, approval of the central government is needed for implementing the decision of E.C. The proposal has accordingly been referred to MoRTH for approval.
- 3. In order to ensure swift disposal of cases, it has been decided that till the decision of MoRTH is received on NHAI's proposal, the powers related to Section-38 regarding Construction on highway land of the Control of National Highways (Land & Traffic) Act, 2002 shall be exercised by Regional Officers of NHAI on behalf of Chairman. An intimation of all such permissions granted may be sent for perusal of Chairman. It has also been decided that all cases relating to permission to M/s Power Grid Corporation may be sent for approval of Chairman through the concerned Technical Division at HQ.
- 4. In so far as the payment of charges is concerned, the matter is being examined separately and final decision would be conveyed in due course. Till the time, a decision is conveyed on this, the guidelines issued by MoRTH in this regard which are in vogue at present may be followed.
- 5. All ROs are requested to take necessary action in the matter accordingly.
- 6. This issues with the approval of Competent Authority.
