The alignment proposed by M/s Maharashtra Information Technology Corporation Ltd. is from km 277.100 (Shegaon T Point) to km 290.750 (Khamgaon Bypass) & crossing Chainage (i) km 277.100 (ii) km 284.950 (iii) km 288.000 & Khamgaon City (i) Ch. 001.300 Total length = 13.65 km in the State of Maharashtra. The following activity is involved:
  - Overhead Optical Fiber Cable to be laid through existing poles of MSEDCL on through erecting new poles at edge of ROW from 277.100 (Shegaon T Point) to km 290.750 (Khamgaon Bypass) and 4 nos of crossings at Chainage (i) 277.100 (ii) 284.950 (iii) 288.000 & Khamgaon City (i) Ch. 001.300.
- As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
