

Sub: Proposal of grant of permission of laying OFC cables (along 2 ducts) of M/s Jio Digital Fiber Private Limited in between NH-52 (old NH-211) from Beed bypass T-point km 184.000 to Padalsingi km 197.400 length 13.400 km and Beed bypass T-point km 184.000 to Beed bus stand km. 179.400 length 4.600 km for total length of 18 km. in the State of Maharashtra- Reg.

It is to inform all concern that M/s Jio Digital Fiber Private Limited vide letter under reference (ii) has submitted a proposal for the subjected work and PD, has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

- 2. The alignment proposed by M/s Jio Digital Fiber Private Limited is for laying OFC cable along NH-52 (old NH-211) from Beed bypass T-point km 184.000 to Padalsingi km 197.400 (length 13.400 km) and Beed bypass T-point km 184.000 to Beed bus stand km. 179.400 (length 4.600 km) for total length of 18 km in the state of Maharashtra. The following work is included:
 - Laying of underground Optical Fiber Cable from Beed bypass T-point km 184.000 to Padalsingi km 197.400 (length 13.400 km) and Beed bypass T-point km 184.000 to Beed bus stand km. 179.400 (length 4.600 km) at the edge of ROW using trenching method.
- 3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
