It is to inform all concern that M/s Telesonic Networks Ltd. vide letter under reference (ii) has submitted a proposal for the subjected work and PD, NHAI, PIU-1, Nagpur has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.


2. The alignment proposed by M/s Telesonic Networks Ltd. is on Borkhedi - Jam-Wadner section of NH-7 chainage km 75.200 to km 75.500 for total length 300m. The following work is involved-

- Underground Optical Fiber Cable to be laid in duct in utility corridor from km. 75.200 to km 75.500
- Crossing by HDD method at Ch 75.500 on Nagpur Hyderabad section.

3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).

In view of the above, the comments / objections of affected public is hereby invited with reference to the Ministry's circular dated 22.11.2016 due to above underground line on the subjected stretch.
