- 1). The subject proposal is requesting permission for laying of Water Pipe Line along NH-47 from Km 4/890 to Km 7/400 2510m (RHS) by Open Trench Method in the project of Salem Kumarapalayam section of NH-47 in the State of Tamil Nadu.
- 2). The Executive Engineer, Tamilnadu Water Supply and Drainage Board, RWS Division, Salem has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, if NHAI considers if necessary in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 90 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No.RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.

As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by the Executive Engineer, Tamilnadu Water Supply and Drainage Board, RWS Division, Salem will be made available for 30 days seeking public comments / objection and shall be furnished within 30 days from the day of closure of public objections.
