

Sub: Proposal for laying / crossing of 11 KV underground electrical Cable at Km.261.400 at Vyalla, Tq. Balapur, District Akola on Amravati – Chikali Section of NH-53 in the State of Maharashtra by the Executive Engineer, MSEDCL, CCO&M Rural Division, Akola-Reg.

It is to inform all concern that the Executive Engineer, MSEDCL, CCO&M Rural Division, Akola vide letter under reference (ii) has submitted a proposal for the subjected work and PD, NHAI, PIU, Amravati has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

- 2. The alignment proposed Executive Engineer, MSEDCL, CCO&M Rural Division, Akola for crossing of 11 KV underground Electrical Cable at Km.261.400 at Vyalla, Tq. Balapur, District Akola on Amravati Chikali Section of NH-53 in the State of Maharashtra is as detailed below:
 - One crossing Km.261.400 at Vyalla, Tq. Balapur, District Akola
 - The Crossing will be done through HDD method and without causing any damages to highway assets.
- 3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
- 4. In view of the above, the comments / objections of affected public is hereby invited with reference to the Ministry's circular dated 22.11.2016 due to shifting / crossing of above water supply pipelines on the subjected stretch. The objections / comments may be addressed to the below mentioned address upto 05.05.2021, beyond due date, no comments/ objections will be accepted.
