M/s Torrent Gas Private Limited, Kota vide letter dated 11.06.2020 (Ref.5) submitted the compliances of the observations and the subject proposal was re-examined and M/s Theme Engineering Services Pvt. Ltd. vide letter dated 14.07.2020 (Ref.6) submitted observations regarding 33Kv high voltage transmission pole at Ch. 1142.987 (LHS).
