SUB: Six Laning of Mota Chiloda to Nana Chiloda from existing Km 494+410 to existing Km 509+550 of NH-8 in the state of Gujarat on EPC Mode under NHDP Phase-V (Package-VII). - Reg. Proposal seeking ROW Permission for laying of 140mm PVC Pipeline along NH-48 from Km 548+740 to Km 550+772 (RHS) and across NH-48 at Km 548+750 section of Mota-Chiloda to Nana Chiloda of NH-48 in the state of Gujarat.


