 - Proposal seeking ROW permission for laying proposed 125mm Ø MDPE Gas Pipeline along NH-151 (i) from Km 30/020 to Km 30/210 (RHS), (ii) from Km. 33/870 to Km. 33/920 (RHS)& across NH-151/Old NH-8D at (i) 30/110 Km (LHS to RHS)- 125 mm Ø MDPE and (ii) at 33/870 Km (LHS to RHS)- 125 mm Ø MDPE (Jetpur-Somnath) near Khamdhrol Chowkdi & Zanzarda Chowkdi to develop city Gas Distribution network in Junagadh District in the state of Gujarat.
