JIO Digital Fibre Private Limited - Request for permission to lay underground Optical Fibre Cable[OFC] on [Salem - Cochin Road(L&T Bypass Road)] of NH-544 between Km:142/375 to Km:143/170 [LHS] of NH-544. in the limits of National Highways, Coimbatore - Reg.

- 1. The proposal is regarding permission for laying Optical Fibre Cable by M/s. JIO Digital Fiber Pvt. Ltd. in NH-544 Road (Salem Cochin Road) along the road from Km 142+375 to Km 143+170.
