Of NH-52 at Shelgaon Phata, near Pargaon Toll Plaza in the State of Maharashtra- Reg.

It is to inform all concern that M/s Re New Solar Power Pvt. Ltd. under reference (2) has submitted a proposal for the subjected work and PD, NHAI, PIU, Aurangabad has recommended the above proposal vide letter under reference (1) for approval of the Competent Authority / Highway Administrator.

2. The alignment proposed by that M/s Re New Solar Power Pvt. Ltd. is along Yedshi - Aurangabad Section of NH-52 (old NH-211) in the State of Maharashtra is as follows:

- Crossing overhead 220 KV DC Tower Line at Ch. 129.73.5 on NH-52 at edge of ROW.

3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
