Subject: - Proposal of permission for laying of 66 KV S/C line from 132 KV Chandkheda S.S to 66 KV Adalaj S.S. with 1600 sq.mm (3+1) underground cable laying work under Kishan Survoday Yojana Phase-2 along at km 20/655 to km 20/875 on NH-147 in the State of Gujarat-Reg.

The Roads and Building Department, Government of Gujarat vide letter no. NHP-11-2025-794-M dated 23.09.2025 has recommended the subject cited proposal for laying 66 KV UG cable laying from 132 KV Chandkheda S.S to 66 KV Adalaj S.S. with 1600 sq.mm (3+1) for underground cable laying work under Kishan Survoday Yojana Phase-2 along at km 20/655 to km 20/875 on NH-147 in the State of Gujarat for approval of Highway Administration cum RO, Gandhinagar.
