Sub: Improvement, Operation and Maintenance including strengthening and widening of existing 2- lane road to 4 - lane dual carriageway from Km.09.200 to Km. 50.000 of NH-6 (Nagpur-Kondhali Section) in the State of Maharashtra on BOT basis - Proposal to lay underground electrical cable crossing National Highway at 11 KV XLPE cable 185 sqm National Highway at crossing 20.779 on NH-53 from Gondkhairi Ta. Kamlmeshwar, Dist. Nagpur in Nagpur - Kondhali section of NH-6-Reg.
