Sub: NHAI-PIU-NSK-Widening of existing 2 lane carriageway to 4/6 lane divided carriageway configuration for Vadape-Gonde (Km 539.5-Km 440) section of NH-3 in the State of Maharashtra - M/s MSKVY Twentieth Solar SPV Ltd.'s for Laving of 11KV HT Electric Overhead Line on RSJ Pole from Km. 454.200 to Km. 454.600 on LHS alongwith NH-3 & Crossing Underground Cable at Km. 454.200 across NH-3.

M/s MSKVY Twentieth Solar SPV Ltd., Igatpuri vide letter cited above has submitted Proposal for Laying Overhead 11 KV Electrical Line on RSJ Poles along with (Vadape-Gonde Section) of NH-3 for approval of the Competent Authority, Highway Administration.

- 2. From the submitted proposal, it is observed that, the Laying Overhead Electrical Line is proposed along with (Vadape-Gonde Section) from 454.200 to 454.600 LHS (Length 0.400 km) on NH-3 & Crossing Underground Cable at Km. 454.200 across NH-3.
- 3. As per Para-4 of Ministry of Road Transport & Highways (MoRT&H) Circular No. RW/NH-33044/29/2015/S&R(R), Dtd. 22.11.2016, the Highway Administration shall put out in the Public Domain for 30 days for seeking claims and objections (On grounds of Public inconvenience, safety and general public interest).
