It is hereby reported that joint field verification has been done today on 04.08.25 for the above mentioned work for laying pipe lines of Mega pipe water supply to Koksara block scheme along the road of NH-26 from Km.226.900 (Moter) to 253.198(Ampani) at different locations in presence of myself (J.E. N.H. section, Ampani), JE(RWSS section, Koksara) and Site Engineer (Executing agency of Mega Project).

The following stretch of NH-26 have been inspected and verified for the feasibility of laying of pipelines.

Checklist sl no. 1.12 & 1.13 are to be corrected as the existing carriageway is of 2 lane with paved shoulder (From Km.226.900 to Km.239.280) and 2 lane (from 239.280 to 259.000) and proposed widening projectfrom Km.239.280(Koksara) to Km. 294.280(Nabarangpur) of NH-26 which covers the stretch from Sl. no. 7 to sl.no. 14.

The pipeline will be laid at 1.20m depth from ground level and 7.00m distance from centre line of the road as they have applied and mentioned in drawings but it is recommended to be laid at extreme edge of the embankment where possible to avoid any damages to road.




