- 1). The subject proposal is requesting permission for laying of 600mm Dia underground Sewerage system along the NH-44 by Trench Method from Km 203/120 to Km 203/550 (RHS) and Km 203/090 to Km 203/550 (LHS) and 800mm Dia casing Pipe line by HDD Method across @ Km 203/550 in the project of Thumbipadi to Namakkal section of NH-44 in the State of Tamil Nadu
- 2). The Commissioner, Salem City Municipal Corporation Salem has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, if NHAI considers if necessary in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 90 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No.RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.

As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by the Commissioner, Salem City Municipal Corporation Salem will be made available for 30 days seeking public comments / objection and shall be furnished within 30 days from the day of closure of public objections.
