3. PIU vide letter dated 06.01.2023 (Ref.6), requested M/s L N Malviya Infra Projects Pvt. Ltd. to re-examine the proposal in accordance with Ministry's guidelines and submit comments/ recommendations. Future, M/s L N Malviya Infra Projects Pvt. Ltd. vide letter dated 31.01.2023 (Ref.7) has recommended the proposal for onward submission to Competent Authority.

4. In the Matter, PIU vide letter dated 06.02.2023 (Ref.8) informed, Executive Engineer PHED Project Div.-Baran that Bank Guarantee amounting to Rs. 30,000/- is to be submitted to this office before onward submission to Competent Authority i.e. NHAI, RO - Jaipur for granting permission. In this regard, Executive Engineer PHED Project Div.-Baran vide letter dated 28.02.2023 (Ref.9) submitted Bank Guarantee no. 35260IGL0001323 Amount 30,000/- valid upto 26.05.2023.

5. In response to above, PIU vide letter dated 09.03.2023 (Ref.10), requested to Canara Bank Subzi Mandi to confirm issuance of the aforesaid Bank Guarantee & its genuineness and provide the system generated report duly signed by Branch Manager regarding linking our account with BG under SFMS Platform & the same has been verified on SFMS portal on 16.03.2023.

In view of above, the subjected proposal is recommended for approval of Competent Authority for granting permission.




