Sub: NHAI - PIU, Salem - Proposal for laying of underground Optical Fiber Cable (OFC) of 100mm Dia HDPE pipe along the NH-44 from Km 201/000 to Km 201/100 (LHS) & Km 201/100 to Km 201/488 (RHS) and across the road by HDD Method at Km 201/000 - 60m, 201/488 - 45m by M/s Jio Digital Fibre Private Limited, Chennai - Approval requested - Reg

- The subject proposal is requesting permission for laying of underground 1). Optical Fiber Cable (OFC) along the NH-44 by Open Excavation of 100mm Dia HDPE pipe from Km 201/000 to Km 201/100 (LHS) & Km 201/100 to Km 201/488 (RHS) and across the road by HDD Method at Km 201/000 – 60m, 201/488 - 45m in the project of Thumbipadi - Namakkal section of NH-7 in the State of Tamil Nadu.

M/s Jio Digital Fibre Private Limited, Chennai has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, if NHAI considers if necessary in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 90 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No.RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.
