- (i) License Agreement may be furnished on Government prescribed stamp paper only as per Ministry's guidelines and name, designation & complete address of the witnesses may be mentioned in the License agreement.

Resolution: We are submitting Licence Agreement along with this letter.

- (ii) Copy of the power of attorney of authorized signatory is required to be enclosed with the proposal.

Resolution: CMO in whose name project is addressing is doing every correspondence by his Own.

- (iii) An undertaking may be furnished that necessary alteration including complete removal/shifting of the pipelines at its own cost if required by Ministry, for the development of National Highway or in the interest of safety in this section.

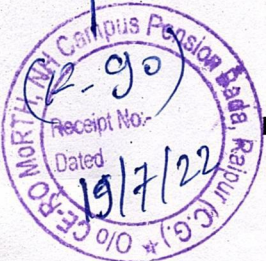
Resolution: We are submitting Undertaking along with this letter.

- (iv) An undertaking may be furnished with respect to all safety measures like barricading, danger lighting and other necessary caution boards during construction and maintenance activities.

- (v) An undertaking may be furnished with respect to ensure safety and security of all underground/overhead installations/utilities/facilities and shall be solely responsible for compensation/indemnification of concerned authority for damage caused/claims or replacements sought for at the cost and risk of licensee.

- (vi) An undertaking may be furnished with respect to ensure that minimum disruption of traffic and no damage to the highways.

- (vii) Safety clearances from the concerned Department for the same and any other statutory clearances as applicable may be furnished.

Resolution: It's a drinking water underground pipeline, so unlike petroleum pipeline National safety council certificate is not required.

- (viii) Detailed calculation sheet of License fee and bank guarantee has not attached with the proposal. This needs to be submitted as per Ministry's guidelines along with supporting documents.

Resolution: Detail calculation Sheet is furnished along with this letter for your review with supporting document.

- (ix) A cross sectional drawing may be furnished where pipeline is crossing of National Highway road.

Resolution: Cross section drawings attached with this letter.

- (x) No. of crossings (if any) along with chainage & ROW needs to be mentioned in the strip plan.

Resolution: Mentioned in the drawing & attached with this letter.

- (xi) Detail chainages of laying water pipeline along and across on NH may be mentioned in the subject of forwarding letter as well as checklist for more appreciation.

Resolution: Chainages mentioned in subject.

Requesting you please provide NOC as earliest so that we can start laying and provide drinking water to people of respective area as earliest. Thanking you.
