- SUB: Four Laning of Ahmedabad to Godhra Section of NH-59 from Km 4+200 to Km 122+420 in the state of Gujarat on DBFOT Basis under NHDP Phase-III.
 - Proposal for ROW permission for laying and crossing proposed 12" Steel & 6" Steel Gas Pipeline Along NH-47 From Km 89+729 to Km 89+181 (RHS)(Line-3), from Km 89+181 to Km 79+851 (LHS)(Line-3), from Km 80+147 to Km 76+316 (RHS)(Line-6), Asphalt Road Km 89+834 to Km 89+729 (To Sevaliya) Approach Road-105+24 Mt. (Line-3), Asphalt Road Km 79+851 to Km 80+023 (To Balasinor)-Approach Road-72+34 Mt. (Line-3) & Across NH-47 at Km 89+181 (Line-3), at Km 80+147 (Line-6)(Ahmedabad Indore) to develop City Gas Distribution Network in Ladvel, Sevaliya, Balasinor and its surrounding area of Kheda & Mahisagar GA.
