It is kindly submitted that the proposal for seeking permission for Erection of 2.0 MW Over Head Transmission (22 KV) in 6 Lay Power Cables Line & Poles along the ROW from Km 41+050 to Km 41+180 on RHS, from Km 41+180 to Km 42+500 on LHS and across the road at Km 41+180 on NH-209 in the aforesaid Project Highway has been requested by the Authorized Signatory, M/s Eternal Renewables Pvt. Ltd., Pollachi vide ref. 1st cited.

The same has been forwarded to Independent Engineer vide this office letter 2. reference 2nd cited to verify the proposal on ground and invited comments along with the consent of the Concessionaire since the Proposal is under the Construction phase.

3. In turn, the Independent Engineer vide ref. 4th cited has replied that the proposal has been verified and submitted certain observation. In turn, the applicant vide ref. 5th cited has submitted the compliance to the IE's observation after attended the site inspection with IE. Again, the revised proposal has been forwarded to IE for verification.

4. In this context, the Independent Engineer vide ref. 7th cited has replied that the proposal has been verified and submitted no objection along with the consent of the Concessionaire (ref. 3rd cited).

5. The above proposal has been scrutinized in light of Ministry's Circular No. RW/NH-33044/29/2015/S&R (R) dated 22.11.2016 and the following points are put forth for kind approval,

- i. The applicant i.e., M/s Eternal Renewables Pvt. Ltd., Pollachi has proposed to construct 2 MW solar power plant at Boduvarpatty village and the work has just been initiated and hence, the applicant has submitted the proposal for erection of 22 KV overhead power transmission line from the solar site to Sinthalavadanpatty Substation which has to be along the ROW from Km 41+050 to Km 41+180 on RHS, from Km 41+180 to Km 42+500 on LHS and across the road at Km 41+180.
- ii. A plan showing the above mentioned NH stretch with the proposed 22 KV overhead power transmission line location has been incorporated in the proposal.
- iii. The overhead power transmission line is proposed to be erect at the extreme edge of RoW (i.e., 1.5m from the edge of ROW to C/C of pole, the distance has been considered as per the existing boundary wall & its foundation and working space for erecting pole).
- iv. The Authorized Signatory, M/s Eternal Renewables Pvt. Ltd., Pollachi has submitted a license deed in the prescribed format to be executed in case the approval is accorded along with indemnity bond.
- v. The Authorized Signatory, M/s Eternal Renewables Pvt. Ltd., Pollachi has submitted the necessary undertakings in the prescribed format as mentioned in the Ministry Circular No. RW/NH-33044/29/2015/S&R (R) dated 22.11.2016.
- vi. Further, the applicant has applied in the "Right to Access" Web Portal for approval (Application No: 20230529/2/15/9715/2841).
- vii. Regarding License Fees and Performance Bank Guarantee, the applicant has calculated wrongly and the same have been modified in this office and submitted herewith for perusal.

6. With reference to the above Ref (2&3), wherein Authority has requested to inspect the site and examine the proposal for execution of 2.0 MV Over Head Transmission in 6 lay power cable line & poles along the ROW from Km.41+050 to Km.42+500 on LHS and across the road at Km.41+050 & Proposal for erection of 5.0 MV Over Head Transmission in 3 lay power cable line & poles along the ROW from Km.41+500 to Km.43+076 on RHS and across the road at Km.42+500 on NH-209(NH-83) respectively.

Based on the request of Authority, a site inspection along with the Concessionaire and Representative of Mr. Eternal Renewables Pvt Ltd and Independent Engineer was conducted on 14.06.2023. And as per clause 11.3 of Concession Agreement "The Concessionaire shall allow, subject to such conditions as the Authority may specify, access to, and use of the site for laying telephone lines, water pipes, electric cables or other public utilities. Where such access or causes any financial loss to the concessionaire, it may require the user of the site to pay compensation or damages as per applicable laws".

However, we noticed that in reference letter ref (3), proposal of 41+050 to 42+500 on LHS, the pole No. 26,27,28 & 29 are marked at 28.5 mtr offset from the center line duly considering the 60 mtr ROW. But, as per our site, at chainage Km.41+110 to 41+160, provision of Highway nest mini to be constructed as per Concession Agreement and additional land acquisition is under process for another 20mtr width beyond the 60mtr ROW.

In this regard, with both of the proposals, Concessionaire & IE have no Objection for allowing access and further confirming that, there will be no financial loss for Concessionaire during the erection time if all the stipulated guidelines of Ministry are followed by the executing agency.

Hence, we request to Mr Eternal Renewables Pvt ltd to get revised proposal for LHS before submitting to Authority by verifying the Ministry guideline duly correcting the poles 26,27,28 & 29 from 28.5mtr from center line to 48.5 mtr from center line, so that the erecting of poles will be within the utility corridor as per provision of Concession Agreement.

With reference to the above SI.No. 1&2, wherein Authority has requested to inspect the site and examine the proposal for execution of 5.0 MV Over Head Transmission in 3 lay power cable line & poles along the ROW from Km.41+500 to Km.43+076 on RHS and across the road at Km.42+500 & Proposal for erection of 2.0 MV Over Head Transmission in 6 lay power cable line & poles along the ROW from Km.41+050 to Km.42+500 on LHS and across the road at Km.41+050 on NH-209 respectively, in order to furnish our consent to Independent Engineer.

Based on the request, a site inspection along with the representatives of Independent Engineer was conducted on 14.06.2023. And as per clause 11.3 of Concession Agreement "The Concessionaire shall allow, subject to such conditions as the Authority may specify, access to, and use of the site for laying telephone lines, water pipes, electric cables or other public utilities. However, we noticed that in reference letter SI.No.2, proposal of 41+050 to 42+500 on LHS, the pole No,26,27,28 & 29 are marked at 28.5 mtr offset from the center line duly considering the 60 mtr ROW. But, as per our site, at chainage Km.41+110 to 41+160, provision of Highway nest mini to be constructed as per Concession Agreement and additional land acquisition is under process for another 20mtr width beyond the 60mtr ROW.

Hence, we request independent engineer to get revised proposal for LHS before submitting to Authority by verifying the Ministry guideline duly correcting the poles 26,27,28 & 29 from 28.5mtr from center line to 48.5 mtr.from center line, so that the erecting of poles will be within the utility corridor as per provision of Concession Agreement.
