1. Invitation of public comments for the following proposals:-

Subjects:-

- I) Permission proposal for laying underground water supply pipe along the road from Km 120/000 to Km 123/000 (RHS), Km 136/700 to Km 138/250(RHS) and Km 143/450 to Km 144/680 (RHS) of NH-49(New NH-87) (Ramanathapuram- Rameswaram section) in the state of Tamil Nadu- for a total length of 5780m- Reg.
- II) Permission proposal for laying underground water supply pipe along the road from Km 122/736 (Existing Ch: Km 123/000) to Km 127/025(Existing Ch: 127/289) of NH-49(New NH-87) (Ramanathapuram- Rameswaram section) in the state of Tamil Nadu -for a total length of 4289m- Reg.
- III) Permission proposal for laying underground water supply pipe along the road from Km 127/025 (Existing Ch: Km 127/289) to Km 136/400(Existing Ch: 136/700(RHS)), Km 137/800(Existing Ch: 138/250) to Km 143/000(Existing Ch: 143/450(RHS) & Km 144/200 (Existing Ch: 144/680) to Km 154/950 (Existing Ch.155/423(RHS) of NH-49(New NH-87) (Ramanathapuram- Rameswaram section) in the state of Tamil Nadu- for a total length of 25325m- Reg.

2. The above subject proposals are regarding requesting permission for laying under underground water supply pipeline along the road of NH-49(New NH-87) (Ramanathapuram- Rameswaram section) in the state of Tamil Nadu by the Executive Engineer, TWAD Board, Project Division(RCWSS), Ramanathapuram submitted to this office by the SE (NH), Madurai vide letter No.2357/2023/JDO dated 16.11.2023(received on 21.11.2023). The permission cases have been examined and following are brought out:

**Subject: (I) Permission proposal for laying underground water supply pipe along the road from Km 120/000 to Km 123/000 (RHS), Km 136/700 to Km 138/250(RHS) and Km 143/450 to Km 144/680 (RHS) of NH-49(New NH-87) (Ramanathapuram- Rameswaram section) in the state of Tamil Nadu -Regarding**

- a) The alignment proposed by the Executive Engineer, TWAD Board, Project Division(RCWSS), Ramanathapuram is to laying underground water supply pipe along the road from Km 120/000 to Km 123/000 (RHS), Km 136/700 to Km 138/250(RHS) and Km 143/450 to Km 144/680 (RHS) of NH-49(New NH-87) (Ramanathapuram- Rameswaram section) in the state of Tamil Nadu i.e. in a length of 5780m as detailed under:

The carriageway width of stretch from Km 120/000 to Km 123/000, Km 136/700 to Km 138/250 and Km 143/450 to Km 144/680 of NH 209 is 10.00m. The Executive Engineer, TWAD Board, Project Division, Ramnathapuram has proposed to lay the underground Public Utility at edge of the ROW for a length of 5780m by adopting open trench method along the National Highway.

**Subject:(II)** Permission proposal for laying underground water supply pipe along the road from Km 122/736 (Existing Ch: Km 123/000) to Km 127/025(Existing Ch: 127/289) of NH-49(New NH-87) (Ramanathapuram- Rameswaram section) in the state of Tamil Nadu -for a total length of 4289m- Reg.

- a) The alignment proposed by the Executive Engineer, TWAD Board, Project Division(RCWSS), Ramnathapuram is to laying underground water supply pipe along the road from Km 122/736 (Existing Ch: Km 123/000) to Km 127/025(Existing Ch: 127/289) of NH-49(New NH-87) (Ramanathapuram- Rameswaram section) in the state of Tamil Nadu i.e. in a length of 4289m as detailed under:

The Executive Engineer, TWAD Board, Project Division(RCWSS), Ramanathapuram has proposed to lay the underground Public Utility at edge of the ROW for a length of 4289m by adopting open trench method along the National Highway.

- a) The alignment proposed by the Executive Engineer, TWAD Board, Project Division(RCWSS), Ramanathapuram is to laying underground water supply pipe along the road from Km 127/025 (Existing Ch: Km 127/289) to Km 136/400(Existing Ch: 136/700(RHS),Km 137/800(Existing Ch: 138/250) to Km 143/000(Existing Ch: 143/450(RHS) & Km 144/200 (Existing Ch: 144/680) to Km 154/950 (Existing Ch.155/423(RHS) of NH-49(New NH-87) (Ramanathapuram- Rameswaram section) in the state of Tamil Nadu i.e. in a length of 25325m as detailed under:

- b) The Right of Way in the stretch of NH proposed for laying Water pipe line is 37.50 to 60.00m. The carriageway width of stretch from Km Km 127/025 (Existing Ch: Km 127/289) to Km 136/400(Existing Ch: 136/700(RHS),Km 137/800(Existing Ch: 138/250) to Km 143/000(Existing Ch: 143/450(RHS) & Km 144/200 (Existing Ch: 144/680) to Km 154/950 (Existing Ch.155/423(RHS) of NH 49 is 10.00m. The Executive Engineer, TWAD Board, Project Division, Ramanathapuram has proposed to lay the underground Public Utility at edge of the ROW for a length of 25325m by adopting open trench method along the National Highway.

3. The Executive Engineer, TWAD Board, Project Division(RCWSS), Ramanathapuram has furnished an undertaking to the effect that they will remove the laid Public Utility water pipe line in future if required by NH wing of State Highways Department, Tamil Nadu/MoRTH, Government of India at any time for expansion of the NH at their own cost without claiming any compensation from NH wing of Tamil Nadu/MoRTH, Government of India and any right on the NH land. Further, mentioned that, the Executive Engineer, TWAD Board, Project Division(RCWSS), Ramanathapuram will also restore the ROW surfaces to its original condition soon after removal of the Public utility water pipe lines. Also, certified that the proposed Public Utility work will not affect the design, stability, traffic safety and future improvement of the proposed stretch.
