The subject proposal is requesting permission for laying of Water pipeline along the existing road at Km.183/700 to Km.183/760 (2 line) (LHS) & across Km.183/700 of NH-45A for a total length of 190m in Karaikal District in the project stretch of Sattanathapuram to Nagapattinam Section of NH-45A (New NH-32) in the State of Tamil Nadu and UT of Puducherry by M/s. Chemfab Alkalis Karaikal Limited, Karaikal in accordance with Ministry's latest guidelines Dt.22.11.2016.

2. M/s. Chemfab Alkalis Karaikal Limited, Karaikal has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, if NHAI considers it as necessary, in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 90 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No.RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.

3. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by M/s. Chemfab Alkalis Karaikal Limited, Karaikal will be made available for 30 days seeking public comments / objection and shall be furnished within 30 days from the day of closure of public objections.
