### Invitation of Public Comments

The proposal regarding issuance of NOC for laying of 12 inch steel Gas Pipeline alongwith OFC cable along Jammu Ring Road from Km 0+00 to Km 3+352 (LHS) in the UT of J&K (3352m in length) has been submitted to this office by PD, PIU Jammu letter No. 11042/1/2017/PIU-JMU/RR/685 dated 06.03.2024 in accordance with Ministry guidelines dated 22.11.2016.

2. The submitted proposal is in conformity with Ministry's latest guidelines dated 22.11.2016 regarding accommodation of public and industrial utility services along and across National Highways.

3. M/s GAIL India Ltd has furnished an Undertaking to the effect that they will shift the utility if required at any time owing to expansion of the road or if necessary by the NH Authority at his own cost and risk without claiming any cost from NHAI. Further, they have furnished an undertaking that not to damage other utility, if damaged then to pay the losses either to NHAI or to the concerned agency. The applicant has undertaken to indemnify against all damages and claims by NHAI. Also, certified that the proposed laying of utility will not have any deleterious effect on any of the bridge components and road way safety for traffic.

4. As per the guidelines issued by the Ministry vide letter No. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by M/s GAIL India Ltd will be made available for public comments/objections within 30 days from the date of uploading of this notice.


