Sir,

Please refer to your letter dated 21.04.2025 vide which the proposal for 'Permission of crossing proposal of U/C 400KV D/C Quad moose PVUNL (Patratu) Koderma Transmission line from U/C Bharatmala Project (Varanasi Kolkata) National Highway at Km.308+002' has been submitted with recommendation for further necessary action.

2. The submitted proposal has been examined as per the instructions contained in the Ministry's Circular No. RW/NH-33023/29/2015/S&R(R) dated 22.11.2016, MORTH Policy Guideline dated 24.04.2023, OM, MORTH dated 24.02.2025, and SOP of MoP dated 14.01.2025 and the following are observed:

- (i) As per SOP of MoP dated 14.01.2025 for overhead transmission lines crossing of road/highways/railways the following shall be ensured:
 - (a) At all road crossings, except National Highways, the towers/ poles shall be fitted with normal suspension or tension insulator strings depending on the type of tower. However, for all National Highways crossing, tension type towers/ poles with tension insulator strings shall be used.
 - (b) A minimum of two sets of long rod insulators or two sets of disc insulator strings per phase per circuit shall be used for all National Highways crossings.

- (c) No joints in conductors or earth wire(s) shall be permitted in crossing span.
- (d) The overhead line crossing shall normally be at right angle as far as possible" & as per MORTH Circular No. RW/NH-33044/29/2015/S&R(R) dated 22 Nov. 2016, Clause No. 3.3, wherein it is stated that "The Utility services shall cross the National Highway preferably on a line normal to it or as nearly so as practicable.
- (ii) The various safety clearances as 'applicable' in accordance to MORTH Policy Guideline Dated 22.11.2016 Para (4) has not been submitted.

3. Also, as per Ministry circular issued vide OM no. RW/NH/33044/29/2015/S&R(R) dated 22.11.2016, the application shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).

4. In view of above you are kindly requested to invite Comments of general public for subject captioned proposal on "What's New" of NHAI website & Ministry's web site for 30 days from the date of uploading. Further, the compliance of guidelines as brought out in para 2(i) above and submission of safety clearances in accordance with para 4 of MoRTH guideline dated 22.11.2016 shall be ensured while recommending the proposal for approval of Competent Authority please.
