Invitation of public comments

Subject:- Permission proposal for laying of effluent water pipe line along the road from Km 6/300 to Km 6/940 (RHS), Km 6/940 to Km 7/730 (LHS), Km 7/730 to Km 8/100 (RHS) & Km 8/100 to 8/760 and across the road Km 6/940, Km 7/730, & Km 8/100 of NH-234 (New NH-75) (Mangalore - Villupuram Section) in Vellore District in the state of Tamil Nadu for a total length 2519m (along the road length 2460m & across road length of 59m) - Reg.

The proposal is regarding requesting permission for laying of effluent water pipe line along the road from Km 6/300 to Km 6/940 (RHS), Km 6/940 to Km 7/730 (LHS), Km 7/730 to Km 8/100 (RHS) & Km 8/100 to 8/760 and across the road Km 6/940, Km 7/730, & Km 8/100 of NH-234 (New NH-75) (Mangalore - Villupuram Section) in Vellore District in the state of Tamil Nadu by M/s Taclo Pernambut Tannery Effluent treatment Company Private Limited, submitted to this office by the SE (NH), Chennai vide letter No.1373/2025/Water pipeline - TALCO/AE/NH dated 06.05.2025 (received on 08.05.2025). The proposal has been examined and the details are as under:

2. The Right of Way in the stretch of NH proposed for laying Water pipe line is from 13.00m to 25.00m. The carriageway width of stretch from Km 6/300 to Km 6/940, Km 6/940 to Km 7/730, Km 7/730 to Km 8/100 & Km 8/100 to 8/760 of NH-234 (New NH-75) is 10.00m. M/s Taclo Pernambut Tannery Effluent treatment Company Private Limited, Vellore has proposed to lay the underground Public Utility at edge of the ROW for a length of 2519m by adopting open trench method along the National Highway and HDD method crosses at Km 6/940, Km 7/730, & Km 8/100 the National Highway.

3. M/s Taclo Pernambut Tannery Effluent treatment Company Private Limited, Vellore has furnished an undertaking to the effect that they will remove the laid Public Utility water pipe line in future if required by NH Authority/MoRTH, Government of India at any time for expansion of the NH at their own cost without claiming any compensation from NH Authority/MoRTH, Government of India and any right on the NH land. Further, mentioned that, M/s Taclo Pernambut Tannery Effluent treatment Company Private Limited, Vellore will also restore the ROW surfaces to its original condition soon after removal of the Public utility water pipe lines. Also, certified that the proposed Public Utility work will not affect the design, stability, traffic safety and future improvement of the proposed stretch.

As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016 the application will be made available for public comments and the comments will be invited within 30 days from the day of uploading the same in the web site of Ministry of Road Transport & Highways for public comments.
