Notice inviting Public Comments for C/o 220 KV D/C Single Zebra Transmission Line from Switchyard of 210 MW Luhri Stage HEP (HP) to ISTS network (400/0 K V Nange at Ogli Pooling Station) HP, Permission of NH-305 crossing between Milestone No. 10 to 11 (on Sainj-Aut Section) at chainage km. 10.600 to 10.800 at Village Behna Tehsil Anni, Distt Kullu in between AP-45A/0 and AP- 46/0 of 220 K V D/C single zebra transmission line from switchyard of LHEP-I (HP) to ISTS Network (220/400) KV GIS Pooling station Nanj at Ogli- Reg.

The Chief Engineer (NH), HPPWD vide letter cited under reference above, has submitted the proposal of NOC for C/o 220 KV D/C Single Zebra Transmission Line from Switchyard of 210 MW Luhri Stage HEP (HP) to ISTS network (400/0 K V Nange at Ogli Pooling Station) HP, Permission of NH-305 crossing between Milestone No. 10 to 11 (on Sainj-Aut Section) at chainage km. 10.600 to 10.800 at Village Behna Tehsil Anni, Distt Kullu in between AP-45A/0 and AP- 46/0 of 220 K V D/C single zebra transmission line from switchyard of LHEP-I (HP) to ISTS Network (220/400) KV GIS Pooling station Nanj at Ogli.

2. From the submitted proposal, it is seen that the height of the towers on which the proposed overhead line are hanging are 48.775 m and 45.775 m. The tower on either side is erected at distance of 465 m & 127 m from the centreline of the carriageway. Further, it has been submitted that the minimum clearance between the lowest conductor of the proposed line and NH carriageway is 105.30 m.

3. In view of above, as per Ministry's said guidelines para 4, public comments are invited on the above proposal making claims and raising objections (on grounds of public inconvenience, safety and general public interest) if any within 30 days on public portal i.e., website of Ministry of Road Transport and Highways (morth.nic.in) in Form-A (copy enclosed) for "Accommodation of Public and Industrial Utility Services along and across National Highways".
