Sub: Four laning of Tarsod to Fagne section of NH-6 from km 422.700 to km 510.000 in the State of Maharashtra to be executed as Hybrid Annuity Mode (DBFOT Annuity) Pattern under NHDP Phase-IV (Package-II-B)-Permission of laying and crossing of OFC of M/s Jio Digital Fiber Pct. Ltd. Across National Highway NH-53 for the total length of 6.240 km at Jalgaon city and Nahata Chowk Reg.

It is to inform all concern that M/s Jio Digital Fiber Pvt. Ltd. vide letter under reference (ii) has submitted a proposal for the subjected work and PD, NHAI, PIU, Jalgaon has recommended the above proposal vide letter under reference (i) for approval of the Competent Authority / Highway Administrator.

- 2. The alignment proposed by M/s Jio Digital Fiber Pvt. Ltd. permission for laying OFC of M/s Jio Digital Fiber Pct. Ltd. Across National Highway NH-53 for the total length of 6.240 km at Jalgaon city and Nahata Chowk. The following work is included:
  - Laying underground telecom cable at NH-53 from km 425.707 to km 429.707 (Doordarshan Tower to Ajanta Chowk), from km 425.707 to km 424.707 (BHS) Doordarshan Tower to Manyar Kheda Phata at NH-53.
  - Cable to be crossed 4 nos by HDD method at km 404.400 (Nahata Chowk), km 425.100 (Car Bazar), km 425.700 (Doordarshan Chowk) and km 428.230 (Kalika Mata Mandir)
  - Cable to be laid along highway by trenching in utility corridor.
- 3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
- 4. In view of the above, the comments / objections of affected public is hereby invited with reference to the Ministry's circular dated 22.11.2016 due to above underground line on the subjected stretch. The objections / comments may be addressed to the below mentioned address within 30 days from issuance of public comments, beyond due date, no comments/ objections will be accepted.
