Sub: NHAI - PIU, Salem - Proposal of laying of Underground water pipe line for agriculture purpose by open excavation along the NH-7 from Km 217/992 to Km 218.693.80 - 701.8m (RHS), Km 218.693.80 to Km 219.192.00 - 498.2m (LHS) and across the road by HDD Method at Km 218/693.80 - 60m (RHS to LHS), by Mr.V.Sundaresan S/o. R.Varadharaj, Komarapalayam (Po), Mallur, Rasipuram Taluk, Namakkal District - Approval requested - Reg

- 1). The subject proposal is requesting permission for laying of Underground water pipe line for agriculture purpose along the NH-7 by open excavation of 100mm Dia pipe from Km 217/992 to Km 218.693.80 - 701.8m (RHS), Km 218.693.80 to Km 219.192.00 - 498.2m (LHS) and 200 mm dia Casing Pipe with 100mm dia GL water line by HDD Method at Km 218/693.80 - 60m in the project of Thumbipadi - Namakkal section of NH-7 in the State of Tamil Nadu.
- 2). Mr.V.Sundaresan S/o. R.Varadharaj, Komarapalayam (Po), Mallur, Rasipuram Taluk, Namakkal District has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, if NHAI considers if necessary in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 90 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No.RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.


