
- 1). The subject proposal is requesting permission for laying of underground water pipe line along the NH-544 by Open Excavation of 110mm Dia HDPE pipe from Km 74/222 to Km 74/429 on RHS and across the road by HDD Method of 300mm Dia Casing pipe at Km 74/429 – 58.50m in the project of Kumarapalayam – Chengapalli section of NH-544 in the State of Tamil Nadu.
- 2). Mrs.Dr.Thavamani Devi Palanisawami, Coimbatore has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, if NHAI considers if necessary in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 90 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No.RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.
- 3). As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by Mrs.Dr.Thavamani Devi Palanisawami, Coimbatore will be made available for 30 days seeking public comments / objection and shall be furnished within 30 days from the day of closure of public objections.
