

The alignment proposed by M/s Maharashtra Information Technology Corporation Ltd. for permission for overhead Optical Fiber Cable on existing MSEDCL Pole and / or erecting new poles along NH-52 from km 368.865 to 377.600 (Taluka Office T point to Bhambarwadi village) total length 28.900 in the State of Maharashtra. The following work is included:

- Optical Fiber Cable to be laid on existing MSEDCL Pole and / or erecting new poles or trench along NH-52 at edge of ROW from km 368.865 to 377.600 (Taluka Office T point to Bhambarwadi village) total length 28.900.

3. As per Para-4 of Ministry's Circular No.RW/NH-33044/29/2015/S&R(R), dated 22.11.2016, the Highway Administration shall be put out in the public domain for 30 days for seeking claims and objections (on grounds of public inconvenience, safety and general public interest).
