Reference is invited to Executive Engineer, M/s. Haryana Vidyut Prasaran Nigam Ltd letter dated 21.10.2020 vide which said proposal has submitted to this office permission for laying of electrical cable line along NH-08 (New NH-48) at Ch. 46.777 to Ch. 47.035 (RHS) and crossing at Ch. 46.650 (LHS) on NH-08 Gurugram-Jaipur section of NH-08.

- 2. The said proposal has been examined by Independent Engineer of the Project Gurgaon-Kotputli-Jaipur section of NH-8, M/s. URS Scott Wilson India Pvt. Ltd. IE vide their letter dated 01.01.2021 has recommended for according approval for laying of electrical cable line along NH-08 (New NH-48) at Ch. 46.777 to Ch. 47.035 (RHS) and crossing at Ch. 46.650 (LHS) on NH-08 Gurugram-Jaipur section of NH-08.
- IE, M/s. URS Scott Wilson India Pvt. Ltd. vide their letter dated 01.01.2021 submitted 3. that:
 - 1) The IE has inspected the proposed site on 03.12.2020 along with applicant M/s HVPNL representative. Upon verification of the proposed location for laying the electric line km 46.777 to Km 47.035 (RHS) and crossing of Electric line at Km 46.65 it has been found that the location for laying the electric line is correct.

2) The proposal for crossing the project highway at the said site has been examined by the IE and the same has been found to meet all the criteria necessary for according the permission and they are found to be in order.

After examining the case, our comments are as under:-

There is only one crossing at Km 46.650 for a length of 62.1 m in urban location of the project highway and depth of the Electric line to b e laid is minimum 1.5 meter below the natural ground level.

- There is no Bus Bay facility at the proposed location.
- There is no Truck Lay Bay facility at the proposed location.
- The Service road has already been completed.
- There is one flyover (Km 47.969) towards Delhi approx 1.3 kms ffar from the proposed location.
- 3) We have also worked out the license fee and performance bank guarantee in favour of NHAI which are required to be obtain from the applicant HVPNL, Manesar. The amount for license for laying of 320.1 m (258.0 m + 62.1 m) Electrical Line along and across NH-8 section has been worked to Rs. 434662.04/- based on the prevailing circle rates for the particular area as made available by the applicant duly considering under the category of public utilities for this case as per the guidelines of MoRTH.
- 4) It is calculated at the rate of Rs. 100/- per route meter for cable of size >= 300mm dia/width total length of 326.1 m in NH-8 for Rs. 32010/- on NH-8 initially for a period of five years (extendable if required till satisfactory completion of work) as a security to comply with the requirements of conditions as per MORT&H circulars in this regard. The amount of the deposited for payment of Performance bank guarantee is Rs. 32010/- in this regard. The detailed calculation sheet for working the amount for License fee and performance bank guarantee is attached herewith.
- 5) In view of the above, the IE recommends for permission to be accorded for laying the said Electrical line in favour of the applicant.
- 6) The documents (checklist and drawings) have been signed by the IE and the same are submitted herewith for taking further action.
- 3. Further, IE, M/s. URS Scott Wilson India Pvt. Ltd. vide their letter dated 03.04.2021 submitted that:
 - This has reference to M/s. Haryana Vidyut Prasaran Nigam Ltd. letter dated 21.10.2020 regarding laying of electrical cable line along NH-08 (New NH-48) at Ch. 46.777 to Ch. 47.035 (RHS) and crossing at Ch. 46.650 (LHS) on NH-08, Gurgaon-Jaipur section of NH-08.
 - ii) Proposal has been rechecked for calculation of license free and Bank guarantee Ministry's guidelines issued vide letter no. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016 & Ministry letter RW/JAI/RJ/PS/2017/UTILITY/GENL/1161-1189 dated 16.03.2017 it is found that there are some corrections which have been incorporated.
 - iii) The corrected measurement sheet is attached. Revised license free and Bank guarantee are as under:
 - a) License free (as per Ministry vide letter no. RW/NH-33044/29/2018/S&R dated 22.11.2016 point no. 5 license fees for public utility 33% of total amount) Rs. 194466/-
 - b) Bank guarantee Rs. 200500/-.
- 4. This office vide above referred letter dated 19.04.2021 has requested to applicant to deposit the License fee and Performance Bank Guarantee as per MoRTH Guidelines. Accordingly, XEN TS Division, HVPNL vide above referred letter dated 05.01.2022 has submitted the proof of License Fee of Rs. 1,94,466/- vide Bharat Kosh Receipt No. 2812210004457 dated 28.12.2021 and Performance Security in the form of Demand Draft No. 567590 dated 28.12.2021 to Rs. 2,00,500/- of SBI Bank, Manesar Branch. The license deed amount has been calculated duly considering DLC rate of agricultural land for year 2019-20, IInd half near national highway of respective village (copy of certified DLC rate and

its calculation are also enclosed) and assumed it a public utility provider. HVPNL Gurugram has also submitted an additional undertaking for the said proposal vide their letter dated 05.01.222 "within 07 days of receipt of notice HVPNL will submit any kind of additional license deed amount as when as it was demanded by NHAI/MoRTH".

- 5. Further, while scrutiny of the said proposal some clarification and documents sought from the HVPNL vide this office letter dated 31.03.2022. HVPNL vide above referred letter dated 07.04.2022 has submitted the compliance on the same. The submission of HVPNL has forwarded to IE of the project vide this office letter dated 25.04.2022 for further examination and comments. IE M/s CEG in Jv vide letter dated 28.04.2022 has submitted the recommendation on the said proposal.
- 6. In view of the above, the said proposal has been examined in this office and seems to be found in order. Duly signed checklist & drawings by undersigned is enclosed with the proposal and recommended to grant permission for laying of electrical cable line along NH-08 (New NH-48) at Ch. 46.777 to Ch. 47.035 (RHS) and crossing at Ch. 46.650 (LHS) on NH-08 Gurugram-Jaipur section of NH-08.

The proposal is forwarded for approval please.
