Sub: Proposal for the construction of an approach road & Slab Culvert for existing retail outlet of BPCL at Km. (65.857-65.907) abutting on (LHS) road section of NH-130, at Kh. No.665/1BA, 665/1BHA/2, PH.No.24, Village-Dumarkachhar, Tehsil-Pali, Distt.-Korba, Chhattisgarh

The CE (NH), PWD, Raipur vide letter no. 1970/W/CE/NH/ Raipur dated 24/09/2019 has submitted a proposal for NOC for the construction of an approach road and slab culvert in respect of retail outlet mentioned in the subject above. The applicant has sought relaxation from Ministry's norms stipulated in circular No.RW/NH-33023/19/99-DO.III dated 24.07.2013 for deviations in required distance from intersection with rural roads and has proposed to construct a service road 331m long & 5.5m wide.

2. The Oil Company has requested for relaxation in view of para above. The justification towards relaxation is placed at Annexure-I.

3. As per Ministry OM vide No.RW/NH/33023/19/99-DO.III date 16.03.2016, the Highway Administration will make available the relaxation proposal of Oil Company for public comments, and the comments will be invited within 60 days from the day of uploading. Accordingly, the above relaxation proposal is being uploaded on the website of Ministry and Road Transport and Highways (www.morth.nic.in).
