Sub: NHAI - PIU, Salem - Proposal of Laying of Water Pipe line in NH-7 (Thumbipadi - Namakkal section) along the road from Km 223/350 to Km 224/185 (RHS), Km 227/630 to Km 228/050 (LHS), Km 238/070 to Km 238/095 (LHS), Km 241/310 to Km 241/930 (LHS), Km 241/310 to Km 242/495 (RHS) and crossing @ km 222/345, Km 227/630, Km 238/095 and Km 241/310 by open trench & HDD method by The Executive Engineer, M/s Tamilnadu Water Supply and Drainage Board, Namakkal Approval requested - Reg

- 1). The subject proposal is requesting permission for laying of water pipe line along the NH-7 by open excavation of 150mm Dia pipe from Km 223/350 to Km 224/185 (RHS), Km 227/630 to Km 228/050 (LHS), Km 238/070 to Km 238/095 (LHS), Km 241/310 to Km 241/930 (LHS), Km 241/310 to Km 242/495 (RHS) and 300mm MS Pipe dia water line by HDD Method across NH at km 222/345, Km 227/630, Km 238/095 and Km 241/310 in the project of Thumbipadi Namakkal section of NH-7 in the State of Tamil Nadu.
- 2). The TWAD Board, Namakkal has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, if NHAI considers if necessary in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 90 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No.RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.
