Sub: NHAI - PIU, Salem - Proposal of laying water pipe line in NH-47 (Salem -Kumarapalayam Section) along the road from Km 24/325 to Km 24/787 (LHS & RHS) and crossing @ Km 24/325 by Open Trench & HDD Method for the length of 924 Meters by the Executive Engineer, TWAD, RWS Division, Namakkal - Approval requested - Reg

- 1). The subject proposal is requesting permission for laying of water pipe line along the NH-7 by open excavation of 1118mm Dia pipe from Km 24/325 to Krn 24/787 (LHS & RHS) and 2235mm Casing Pipe dia water . # 1 to 1 to 1 line by HDD Merhod across NH at Km 24/325 in the project of Salem -Kumarapalayam section of NH-544 in the State of Tamil Nadu.
 - 2). The Executive Engineer, TWAD, RWS Division, Namakkal has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, if NHAI considers if necessary in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 90 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No.RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.
 - As per the guidelines issued by the Ministry vide letter No.RW/NH-3). 33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by M/s.TWAD Board, Namakkal will be made available for 30 days seeking public comments / objection and shall be furnished within 30 days from the day of closure of public objections.
