### Invitation of Public Comments

**SUB:** Four laning of Gujarat/Maharashtra Border - Surat - Hazira Port Section of NH-6 (approx. length 131.500 km) in the State of Gujarat under NHDP Phase III.

- Proposal seeking ROW Permission for Crossing NH-53 Hazira-Palsana Highway by exiting 66KV Overhead Tower Line D/C Panther Tower with ASCR Panther Conductor for 66KV D/C Navsari Eklera Line at Km 36+710, near Sachin Over Bridge Bypass Surat in the state of Gujarat.

The Project Director, NHAI, PIU-Surat vide letter u/ref.(1) has recommended the instant proposal submitted by M/s. 
