It is to submit that M/s. NCL Industries Limited, Tallapalem vide reference 1st & 2<sup>nd</sup> cited submitted a proposal seeking permission for Erection of 33KV Overhead Line over M+12 Towers (9 Nos.) & 12.5m Spun poles (30 nos.) from Tallapalem to Narasingibilli from Km.758.695 to 760.790 (LHS) and crossing (HDD) at 760.790Km along NH-16 (Total Length is 2095m+38m=2133m) for extending of 33kvpower supply to M/s. - 2. As per the Revised Circular Guidelines, the Agency submitted an undertaking duly stating that they will submit Performance Bank Guarantee as demanded by NHAI. The applicant has furnished that they will relocate utilities at their own cost for further six laning.
- 3. The above proposal has been forwarded to the IE, M/s. MSV International INC, in Association with Sri Infotech, for verification at site and feasibility report to Concessionaire M/s. Ankapalli Tollways Pvt. Ltd. for consent vide reference 3<sup>rd</sup> cited.
- 4. IE, M/s. MSV International INC, in Association with Sri Infotech, vide reference 4<sup>th</sup> cited recommended the proposals stating that permission may be granted to the applicant for erection of 33 KV overhead line over M-12 towers & 12.5m spun poles at the above location. A copy of the report submitted by the IE is enclosed for ready reference.
- 5. The Concessionaire, M/s. Ankapalli Tollways Pvt Ltd., have submitted their consent for erection of 33KV Overhead Line subject to the provisions of clause 11.3.1 of Contract Agreement.
- 6. The applicant has submitted the Methodology for erection of 33 KV Overhead Line Over M+12 Towers (9 Nos.) & 12.5 m Spun Poles (30 Nos.) along the National Highway-16 at the edge of RoW / Utility corridor from Km. 758.695 To Km.760.790 (LHS), Crossing (HDD) at Km.760.790 on NH-16 and one Pole at RHS (Total Length is 2095m+38m=2133m) for extending of 33 KV Power Supply to M/S NCL Industries Limited.
