## INVITATION OF PUBLIC COMMENTS

Sub:- NHAI-RO Kerala-Operation & Maintenance of Edappally-Vyttila-Aroor section from Km 342.000 to Km 358.750 on NH-66 in the State of Kerala on OMT basis (Package OMT 23) in the State of Kerala-Accommodation of Public and Industrial Utility Service along National Highways-Crossing of 315mm HDPE casing pipe through HDD by KWA at Km.344+295 of NH-66-Reg.

The proposal is regarding permission sought by Kerala Water Authority for Crossing of 315mm HDPE casing pipe through HDD by KWA at Km.344+295 of NH-66 along the subject project stretch in the State of Kerala.

2. KWA has furnished undertaking to shift the HDPE casing pipe at their own cost at an alternate location whenever NHAI make a request for shifting of the same. Further, the applicant has undertaken for confirming with all standards as mentioned in the Ministry's Circular.

3. Further, KWA has undertaken that they will not damage any other utility during the process on laying and in case, if damaged, then to pay the losses either to NHAI or to the agency concerned. Further, KWA has undertaken to bear the expenditure incurred by NHAI for repairing any damages caused to the NH by laying, maintenance or shifting of the proposed water supply line.

4. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by Kerala Water Authority will be made available for 30 days seeking public Comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
