## **Invitation of Public Comments**

SUB: Six Laning of Ahmedabad to Vadodara section of NH-8 from Km 6+400 to Km 108+700 (Length 102+300 Km) and Improvement of Ahmedabad-Vadodara Expressway from Km 0+000 to Km 93+302 in the state of Gujarat (Length 93+302 Km) under NHDP Phase-V on Design, Build, Finance, Operate & transfer (DBFOT) Toll Basis.

Permission for laying of 11KV HT line along NH-48 from Km 8+230 to Km 8+998, on Right Hand Side and Across NH-48 at Km 8+581 (2 nos. of Cables) at District Ahmedabad on Ahmedabad-Vadodara section of NH-48 in the state of Gujarat.
