### Invitation of Public Comments

**SUB:** Construction of 6-lane access-controlled Greenfield highway from km 99+000 to km 130+073 of Rajasthan/Gujarat Border to Santalpur section of NH-754K as a part of Amritsar-Jamnagar Economic Corridor on EPC mode under Bharatmala-Pariyojana (Phase-I) (AJ/RGBS/Pkg-4) in the state of Gujarat.

- Proposal for ROW permission for Overhead Crossing at Km 114+800 of NH-754K in the Sanchoe Santalpur section between Km 114+800 and Km 115+200 near Village- Babra for construction of 220KV D/C Overhead Transmission Line from TPL's 220kV Babra PSS to GETOC's 400/220 KV Charanka PSS.

The Project Director, NHAI, PIU-Palanpur vide letter u/ref.(1) has recommended the instant proposal submitted by M/s. Torrent Power Limited, Ahmedabad vide their office letter u/ref.(2), seeking ROW permission for Overhead Crossing at Km 114+800 of NH-754K in the Sanchoe Santalpur section between Km 114+800 and Km 115+200 near Village- Babra for construction of 220KV D/C Overhead Transmission Line from TPL's 220kV Babra PSS to GETOC's 400/220 KV Charanka PSS in the state of Gujarat.

2. Now, as per Ministry vide OM No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the Highway Administration will make available the proposal seeking permission for utility laying for public comments for **30 days** on the ground of general public interest for seeking claims and objections.


