
- 1). The subject proposal is requesting permission for laying of Optical Fiber Cable (OFC) along the NH-544 by Open Excavation of 12.75" Dia pipe from Km 42/022 to Km 53/525 for the length of 11.503 km in the project of Salem to Kumarapalayam section of NH-544 in the State of Tamil Nadu.
- 2). M/s Indian Oil Corporation Limited, Kallakurichi has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, if NHAI considers if necessary in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 90 days) of the intimation given. Further, the applicant has furnished the undertaking for payment of rent / fee as mentioned in the Ministry's Circular No.RW/NH-33044/29/2015-S&R dated 22.11.2016 as when asked by NHAI.
- 3). As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, the proposal submitted by M/s.Indian Oil Corporation Limited, Kallakurichi will be made available for 30 days seeking public comments / objection and shall be furnished within 30 days from the day of closure of public objections.
