- 1). The subject proposal is requesting permission for laying proposed 24" Dia steel gas pipeline with OFC Duct on NH-544 by Open Excavation from Km 32/800 to Km 53/525 for the length of 20.725 km in the project of Salem to Kumarapalayam section of NH-544 in the State of Tamil Nadu.
- 2). M/s.Gail (India) Limited, Chennai has furnished an undertaking to move the utility line for any work of improvement or repairs to the road, if NHAI considers if necessary in future, it will be carried out as desired by the NHAI at their cost within a reasonable time (not exceeding 90 days) of the intimation given.
